Declarations of candidacy to file for the above office may be obtained from the Alameda County Registrar of Voters Office, 1225 Fallon St. Room G-1, Oakland, CA 94612 on or after July 17, 2006, and no later than 5:00 p.m. on Friday, August 11, 2006.

\*Declarations of candidacy may also be available from the District Secretary.

If an incumbent elective officer of the district has not filed by 5:00 p.m. on August 11, 2006, the nomination period shall be extended until August 16, 2006 for any eligible voter except the incumbent.

In the event there are no nominees or an insufficient number of nominees for such office and a petition for an election is not filed within the time period prescribed by the Elections Code section 10515 for special districts and Education Code sections 5326 and 5328 for school district offices (5:00 p.m. August 16, 2006), the supervising authority will make appointments to each elective office.

The polls will be open between the hours of 7:00 a.m. and 8:00 p.m. on Tuesday, November 7, 2006.
